## Warranty Terms, Disclaimers and Remedies

<b>Warranties:</b>	<p>Verionix warrants that products delivered hereunder shall be free from defects in workmanship and material for the warranty period as stated above, provided that notice of any such defect is provided to Verionix within 30 days of its discovery by the buyer. Products or component parts sold as new or factory-refurbished are warranted under separate terms. Warranty terms applicable will be those in effect at the time of product sale, and are not subject to change should Verionix revise its warranty terms in the future.</p> <p>Verionix further represents that the software for these products will execute their programming instructions, but does not warrant the operation of the product, software, or hardware will not be interrupted or will be error-free.</p> <p>Verionix disclaims any warranty with respect to products modified without Verionix' consent, rendered defective by customer misuse or otherwise compromised by use of unauthorized parts or service, including but not limited to unauthorized tampering with non-field serviceable components, all as determined by Verionix in its sole discretion. Further Verionix disclaims any warranty with respect to Microplasma sources and/or Electronic Control Modules that have been compromised through exposure to corrosive or depositive liquids or gases at any time, whether accidental or in the normal course of operation, all as determined by Verionix in its sole discretion.</p>
